Vachana: Allamaprabhu Vachana by Srishail Hadimani.

Key discussion points:

President welcomed all the members. Emphasized that we all should work together to uphold the vision of VSNA.

Agenda: Girish Buddibetta proposed the agenda be accepted as it is. Dayanand Paramane seconded it.

Introductions:

All officers introduced themselves including Youth President and chapter presidents: High level summary of introductions. Each was requested to:

- State Name and the Chapter you are representing.
- Your top 3 things that you want to see Central VSNA team do?
- Your personal goals for 2019 for your chapter.

All the chapter presidents in summary expressed that Central VSNA should work closely with local chapters to bring commonality and sense of belongingness to central VSNA. Each of the presidents shared what they are currently doing and their plans for this year to take it to the next level. Some of them shared the challenges they are facing and requested central VSNA's assistance in addressing them.

Hadimani covered about open positions: One BOD, 2 BOR and 1 VIRC position.: As per recommendation by the outgoing EC that conducted successful elections, current BOD team would like to request the below confirmations.

VIRC: Mr. G Jagadeesh from MD as VIRC director. Dr Jagadeesh is a scholar and has contributed immensely to VSNA.

Request the approval of BOD present to confirm Prabhakar Chippadi for BOD and Shailendra Kumar for BOR position. Both these individuals had applied for these positions and should be confirmed.

Hadimani suggested that we will call for nominations for the other open BOR position and to secretary position.

Responses from other BOD members:

There was a healthy discussion and debate over the issues. None of the members had any issues in having Dr Jagadeesh be the VIRC director. His contributions to the organization were well recognized and was unanimously approved to lead VIRC.

Regarding the BOD and BOR positions, the debate brought out views of all the members. a few of the members expressed and suggested that one should call for fresh nomination and elections while others made a case for calling for elections to the positions that are left vacant after confirming the two members who had applied but were kept on hold. Some highlights of the views expressed were:

Girish B: Want to call for nominations once again.

Indira Reddy: One should call for nominations and conduct elections once again.

Sanikop: We should appoint people who applied last year for positions that are still vacant. Fresh nominations should be taken only for any open positions that are left after confirming the ones who applied last year.

Dada Patil: Suggested that Prabhakar and Shailendra had applied and we should confirm their nominations. There is no conflict of interest and are not part of any other organization now. In the interest of keeping the community together and acknowledging all the work these two individuals have done, we should confirm their nominations and call for elections for other positions after appointing a new Election committee.

Indira Reddy: No. I want that we should nullify everything and call for nomination once again and conduct elections as many times as required until we fill the positions.

Sanikop: We should honor the two prior nominations and avoid a long legal battle again in the interest of moving forward.

Shiva Patil: Let's not do things that divide the community. Let's accept those two applications and ask for nominations for the new two positions. This will help repair the things.

Asha Gaddi: Let's give chance to these two members. There are still 2 more positions.

Rohini: I would go with Dada's suggestion. We cannot keep conducting elections. There are lot of things that we need to make progress.

Indira: Why not we redo the nominations and go through the election process again.

Sanikop: We don't want to be going in circles. These two members can very easily take the legal route and put the entire VSNA in trouble.

Rohini: Elections are completed. Those two candidates were put on hold. They are cleared from the other organization. They should be part of this committee. Asking life members to do this all over again is a very long and tiring process. This is a charitable organization. Let us put our ego aside. Election committee has recommended that elected officers nominate people for the vacant positions. Let us not make big issues and introduce hurdles to the organization.

Manisha: Those two members were disqualified and why should we appoint them.

Dada: As BOR chair I have full information from both the lawyers. Dada clarified that Manisha the youth president may not have all the details as only half the information was shared by past president.

In order to arrive at a decision and to ensure we follow the democratic process, everyone agreed that this should be put to vote, and outcome of the decision should be binding. As a result, the below Proposal was made.

<u>Proposal:</u> Prabhakar Chippadi and Shailendra Kumar had applied for BOD and BOR positions. Current BOD would like to approve and confirm their nominations for BOD and BOR position respectively.

Shankar Sanikop would like to propose the above point as written above. I don't want us to fight over here in the interest of bringing the community together.

Rohini Menasinkai: I would like to second the proposal. Let's take a vote and democratically decide what should be done. This is a democratic organization and we have quorum here. We should decide as a team in the interest of moving this organization ahead.

Voting Results: 10 Yes, 4 abstain 2 No.

The motion is passed with majority. Which means BOD confirms Prabhakar Chippadi for one open BOD position and Shailendra Kumar for one open BOR position.

Sreeshail Hadimani: We will call for nominations for the remaining BOR position and secretary position that is open by appointing an Election committee which will call for nomination and conduct the elections if required.

Raj: Call for volunteers to be part of ad-hoc committees: We really need expertise and experience of chapter members to be part of some committees. Current thought process is to form 5 committees:

- 1. Review and update the bylaws committee
- 2. Financial advisory committee
- 3. Newsletter committee
- 4. Website committee
- 5. Chapter rejuvenation committee

Raj to send out email requesting each chapter send in 5 names as volunteers for these committees.

Shiva Patil: Treasurer Report: Provided the current balance in each of the account. Still working to get all the details from the past Treasurer. Please send me all the financial reports at chapter level to be able to file our taxes. Please send them by end of next month. Send me the details of all new members also. Initial look at the accounts received shows some expenses that need to be reviewed for proper authorization and other details. 2018 wasn't a great year for market and our value has gone down. Hence all the more need for leveraging and appointing financial advisory committee.

Hadimani: Central VSNA annual membership fees: On an experimental basis, annual membership fees were reduced to \$10 in the last two years. This has come to an end. We would like the approval to re-instating the normal membership due of \$35 for annual membership for central VSNA. Please motivate them to become life or annual members.

There was once again a healthy discussion on pros and cons of doing this. Many had inputs but no consensus was arrived. It was agreed that we should table this discussion for now and take it up again in the next meeting.

Raj: Vote of thanks and next BOD meeting scheduled for Feb 17th, 2019. Everyone was very professional on the call and we will strive to keep it under 2 hours for the next call. Thank you.

Prayers: Hadimani payed a rich tribute to Sri Sri Shivakumar Swami of Siddaganga math. He also explained the meaning of vachana and as mark of respect a one-minute silence was observed.

Approval of agenda: Prabhakar Proposed and Raj Galagali seconded it.

MOM: 2 Corrections:

- 1. Attendance of Dr Sheetal Neral to be marked as Yes for Jan.
- 2. Indira Reddy mentioned that we should communicate the details of nominating the BOD members and be recorded in the meeting minutes.

Girish Buddhibetta proposed it that it be accepted with the two above corrections. Rohini Menasinakai seconded it.

Introduction of new members: Dr Jagadeesh and Prabhakar Chippadi were welcomed and introduced to the meeting as VIRC director and BOD member respectively.

Convention update: Nandish and Veena Hullur presented the update on Chicago Convention. Lots of hard work in progress. Venue is finalized. We will present the budget details in March. Most likely the website will be open in a day or two for registration. Hotel info and some details already present. Early bird \$139 until May 31st. Regular price of \$159. We are expecting 600 people. This may go up. Would request Central VSNA to pass on the details to all members and request chapter presidents to share all this info to everyone. Lot of youth programs on Fri. Evening is 2 hours cultural programs. What can we expect from convention fund?

Contract to the hotel is already complete and deposit is given. Dada suggested that BOD should take up providing the seed money to the Chicago chapter and share the details on how much that needs to be.

Naveen from Pittsburgh: Asked about early bird and other details:

Nandish provided the details: \$99 for to 5-9yrs. Before April 30th registration will be entered in to a raffle. We are also trying to limit the number of guests from India and ensure they have enough time to talk/present. Convention team is working on guest lists.

Priyanka -Ohio: Please send the package and flyer details to us ASAP.

Eastern Pennsylvania Chapter: Annappa Metgud, Sid Tumkur and Shiva Veera introduced themselves and made a strong case to establish new VSNA chapter there. They have 15 families and 44 members now they have critical mass to establish a chapter of their own in the Allentown PA area. They have been informally meeting for the last 2 years. They had General BOD meeting in early 2019. Currently we have 28 families registered. Having Shivaratri program next month and are expecting around 65-70 people. Aligned with the mission and vision of Central VSNA. The core team is also formed now under the leadership of Sid Tumkur. They also have quite a few life members and are looking to increase them to double digits

Proposal: Shankar Sanikop Proposed that Eastern Pennsylvania be recognized as the newest VSNA chapter.

Naveen Kumar of Pittsburgh seconded the proposal.

There were no objections.

Central VSNA annual membership fees: Hadimani presented the history of \$10 and why we should raise it back to at a minimum \$25 from now onwards.

Indira Reddy: Mentioned that we should list the additional benefits clearly in addition to what is already known.

Tej Kartal: What do I get if I am an individual member. The funds were not received by central VSNA treasurer on time. People who paid \$10 in the past were equally eligible to vote. We need to differentiate between Life and annual member benefits. One proposal: Once you collect the funds, that member should not be eligible for voting in the current year. The bylaws are not clear. We need to review each and every section for it and may be have a focused discussion. Dada also suggested that getting a single vote for \$500 and the same for someone paying \$10 needs to be addressed. However, at this time, we are to go by bylaws. There are definitely discrepancies in the current structure. Dada suggested that bylaw committee will suggest the amendments. We need to decide today so that local chapter can decide how much they need to collect at least for this year.

Indira: We get only one vote for a life member. We need to change. Bylaw committee should work on it and amend it to make it fair.

Hadimani: I would like to propose that we make it \$25 for this year as central VSNA annual membership fees.

Dayanand Paramane Proposed that the central VSNA annual membership be \$25 from this year.

Naveen Kumar from Pittsburgh seconded it.

Voting: All members voted it as yes and 3 members did not provide the response. There were no votes who voted against it. Resolution is passed.

Copyright violation: The C&D letter was shared with all the BOD members and the details were presented to everyone. VIRC director was requested to take a look at this issue and provide the findings so that BOD can vote on it based on VIRC director/team's findings and pass a resolution as required. Dada and others suggested that Dr Jagadeesh should provide his inputs to the team based on analyzing both the books.

Call for volunteers to serve on various committees: Received names from NY/NJ and Detroit chapter only. Requesting other chapter members to please send in the names of the members to us soon.

Treasurer Report: Shiva presented that \$6900 was spent on legal expenses without any BOD approval. The explanation provided by previous officers' states that they spent this based on the approval from some seniors and even there it says that any emergency spending should be ratified immediately by calling a meeting of BOD and approved.

Sanikop: We need to get more details from the last team and see if past and current team together can pay back this money.

Indira Reddy:We need to analyze this in detail and ensure we take a correct decision. I don't think any of the existing members need to pitch in to pay back this amount. Dada Patil:He suggested a few things.

- 1. Spending money without BOD approval is a grave mistake. BOD needs to approve any spending over 1000.
- 2. Hiring a lawyer needs BOD approval. This wasn't done in this case.
- 3. Even if money was spent in emergency, the past officers should have called for a meeting to ratify the spending. This wasn't done.
- 4. Auditors will not approve this and Central VSNA may lose our non-profit status and be black listed. Hence, we cannot ignore this.
- 5. Please make this as one of the main items on the agenda for the next BOD meeting and share the details via webex with the BOD so that an appropriate decision is taken.

Shiva: Our trust fund has a loss of \$38,000 last year in our investment. This is only second to 2008 loss when we had \$89000 loss. Hence, we need to discuss how much we pay and how we pay as the seed money to Convention. As a BOD we need to decide

Indira: We would like to see the details of where we lost the money etc before we make a decision.

Shiva: Let's have a webex to share the details to discuss investment details and un authorized spending.

Dada: We need to find ways to pay some seed money to Chicago chapter. We can't punish the chapter just because market did not do well. BOD should come up with some details and agree on the amount.

BOR chair update: Election for BOR chair will be conducted today. We have taken 2 projects this year:

- 1. Go line by line to go over bylaws and present the revisions / recommendations. Headed by Yuvaraj Patil.
- 2. How to teach Basava Philosphy for different age groups at chapter level. Headed by Shiva Sajjan.
- Youth Project / Suggestion to current President Manisha: Get the list of alumni from our VSNA youths who have graduated from schools and see how we can help the next gen younger generations.
- 4. Make a list of emergencies of contact numbers for our VSNA youths by providing them with a local VSNA family / volunteers to help college students. Especially for the first 1-2 years.

Vote of thanks: Next BOD meeting will be on March 17th Sunday starting at noon ET. Thank you to everyone for joining the call.

Approval of agenda: Girish Proposed and Dayanand seconded it and approved the agenda as proposed in the invite.

Approval of Feb BOD Meeting minutes: Prabhakar Chippadi proposed that the MOM be accepted as sent in the email. Vijaya Aivalli seconded it.

Vacancy for BOR and Secretary: Hadmiani presented that one nomination each were received. As a result, Hadimani proposed that Ravi Ambalee from Chicago Chapter be appointed as BOR member and Jayashree Jagadeesh be nominated as Secretary.

Raj Galagali proposed that these two names be accepted for the said position. Vijaya Aivalli seconded these nominations and expressed appreciation for all the services these individuals have contributed to the organization.

Convention update: Nandish, Kiran and Veena Hullur presented the update on Chicago Convention.

Lots of hard work in progress. Want to understand the insurance coverage for the event. Request all chapter presidents to share the flyer with your members as soon as you receive it. Hotel: \$10 resort fee will not be charged even though it shows during booking. Please make reservation via website. Website has all the details including preliminary program details. Treasurer: Targeting and planning for 600 attendees. Obligation / budgeting is being done for 400, 500 and 600 people. \$145K to \$210K. Cost of \$365 per person (400). Kiran presented preliminary budget taking in to consideration 400 as minimum people to 600 as maximum.

Discussion around seed money, possible loan of 5K from local chapter was discussed.

Raj Galagali Proposed the budget be accepted as draft budget for 2019 convention. Prabhakar Chippadi seconded it.

Guest lists: The list is already on the website and all of the guests have been invited. They are working to invite Sri. Siddeshwar Swamiji.

Copyright violation: Dr.Jagadeesh VIRC director submitted the report on "Lingapooja illustrated" copyright issue. The effort and quality of the summary report was of highest standards comparing page by page etc. In summary, Dr. Jagadeesh concluded that this is indeed copyright violation /plagiarizing issue and that central VSNA BOD should decide appropriate next steps.

Prabakar and Shylendra suggested that convention is held under Central VSNA and that we should move ahead in addressing the issue and bring it to closure.

Hadimani concluded that we will respond to the author and bring this issue to closure and President would send out the letter to involved parties.

Going forward, it was suggested that VIRC board should approve any publications if it needs to be distributed during convention.

Call for volunteers to serve on various committees: Received tremendous response from lot of members. We received as many as 20 people for some committees. President will finalize the list and send out the details.

Treasurer Report: Shiva presented on webex a very detailed financial detail.

Details on all the accounts and balances that exist. Shiva also credited the previous teams for doing a wonderful job of getting life members and annual members thereby increasing the revenue to Central VSNA.

Treasurer also presented the detailed accounts and found legal expenses of a total of around \$6929.99 without BOD approval.

Indira Reddy suggested that we need to fix the bylaws to ensure clarity is provided for such scenarios.

Girish B also suggested that we need to find ways to move ahead without getting in to legal battle again.

Treasurer suggested two options: 1. Just approve this and accept the spending. This would mean we also approve spending of other party that has submitted their legal expenses of \$5,735.

Option 2: We write to the past President and treasurer who had the check signing authority to reimburse these expenses to VSNA. Seek written response and request them to provide their response.

The intent here is to ensure that our auditors do not raise this as a red flag, to ensure that the non-profit status of VSNA is not in jeopardy as a result of this spending and finally this does not set a precedence for future actions of similar type.

Prabhakar and Shailendra recused themselves as it would involve conflict of interest. Indira suggested that we should write a letter. We should definitely update the bylaws. Vijay Aivalli said it sets a bad precedent and we should discuss this in GB meeting during convention as well.

Hadimani concluded that based on all the inputs from BOD members, he would write to past president and treasurer seeking written response to this issue as the first step.

Convention Funding: We had a bad year in 2018. Convention trust fund lost around \$38,000. One of the key goals of Central VSNA is to support the local chapter hosting the convention. Treasurer also presented the details on how much was given to each chapter in the last 6 years.

Shailendra suggested that we provide the average of the last 6 years as the convention seed fund. The average comes to around \$15,600.

Proposal: Raj Galagali proposed that \$15,600 should be released as seed fund to Chicago chapter as the host of 2019 convention. This is for 2019 only.

Vijaya Aivalli seconded it and voting was done.

15 voted yes, 1 abstained. The resolution is passed

BOR chair update: Shailendra presented quick update. Shailendra was elected as chair of BOR. Two projects taken up are bylaws and uniform teaching method. Details will be shared in the upcoming meeting.

Vote of thanks: Next BOD meeting will be on April 14th Sunday starting at noon ET. Thank you to everyone for joining the call.

Convention update: Nandish and Kiran Tavane presented the update on Chicago Convention. Lot of hard work has put in and the work is in progress. Requested all chapter presidents and board to take the package and encourage chapter members to register as soon as possible, as there are few allocated rooms available. If need arises, will request for more rooms. Confirmed the receipt of convention seed money.

Kiran: 64 members have registered and 8 packages were taken and drive is one to sell more packages and encourage everyone to be part of the convention. Sought standard convention financial report templet that they can use right from the beginning.

Shylendra: Treasurer needs to keep accurate information on the numbers (Receipt and expenses) also good record keeping in support of the numbers. If the team has internal audit that is good. If there are any above normal expenses, seek board's opinion, please let us know. Manisha: Is there any allocated funds for the youth activities for the convention? How much money we are getting from center for the youth activities?

Shylendra: the convention seed money should cover all the activities; there are no specific central funds available for the youth activities at the convention

Nandish & Kiran: youth activities are self-supported events, and the convention team is getting some quotes for the events, they will have internal discussion and do the needful.

Shylendra: Annual and Life memberships can be enrolled and maintained separate account.

Updates on actions items: Srishail Hadimani presented the status report on actions items from previous BoD meetings

- Emphasized the need of regular attendance at the BoD meeting from all the members, if you cannot make it for the meeting, please delegate VP / Treasurer / Secretary / delegate for the meeting, so that Central message is communicated effectively to all the members.
- 2. Annual membership due date is May 30, 2019, please enroll your chapter members send the check to central VSNA. Also it is required all the Chapter Presidents to be a Life member OR an Annual member. If you are not a member, please do become ASAP.
- **3.** Need to update central VSNA e-mail list (mail chimp), requested to send an updated email list along with the contact information from all the chapter members format to be sent out.
- **4.** Copyright violation: Communicated the Board's decision and shared our analysis report with Deepak Kankeremath, Executor of Vimala Channabasappa Trust regarding Plagiarism issue related to "Ishtalinga Puja Vidhana / Method". The trust accepted our apologies and our report. The issue is resolved.
- 5. Unauthorized spend: Srishail contacted the past president seeking additional information for the spend; the past president has given response which will not stand up the scrutiny of the audit for the reasons responded. Requested sighting the reasons for explanation and have not heard so far., sought board's response / inputs
 - Indira Reddy, wants to see the communications and response from the past president, Srishail said he will share with the board members.
 - Raj: We have requested the president to come for the meeting, explain it. The board can resolve it without spending time and money on this matter; overall we do not want to set a precedent going forward.

Agenda and opening remarks:

Hadimani: Summarized the unauthorized spending of funds by previous administration (\$6,929.99). The goal of this meeting is to find a path forward and bring the issue of unauthorized expenses incident to closure in a way that it doesn't jeopardize the 503(c) status of VSNA and also not set a precedent that encourages such incidents and behavior in the future.

Requested all the chapter presidents and BoD members who were in the meeting to express their opinion and views to arrive at a consensus to resolve the matter in the best interest of the organization.

Expenses incurred by previous administration: Shiva Patil summarized the expenses incurred by the previous administration and efforts made by the current officers in seeking an explanation. Mentioned an outstanding invoice from the other party. The Tax filing due date has been already extended; there is an urgency in resolving this issue prior to the General body meeting.

Raj Galagali: Explained all the steps that were taken by the current administration and laid down the options in detail.

Vijay Aivalli: Organization funds cannot to be used without the board's approval and without following due process. Without which, it is considered as an unauthorized spending and should be recovered.

Budibetta: The other party claiming their expenses and their invoice to be rejected

Mahesh Patil: Any funds spent without authorization, should be recovered from the parties and should not pay the other party.

Indira suggested to seek / consult a legal help or advice within the organization to evaluate and assess the consequences and look into legal angle but refused to take the lead. Opinioned to study the entire issue before we can take any action.

Prabhakar and Shylendra briefed the situation and circumstances that lead to this issue. Most of it could have been resolved by having board discussion and honoring the resolutions that were passed in the meeting.

Manisha: We cannot take action without we fully study the issue and arrive at a conclusion.

Hadimani: we have already spent 6 months in resolving this, as requested by the board I have shared all the communications. Now is the time to act and move on, based on the members voting we will take the next course of action.

The resolution was drafted after a healthy and constructive debate and below resolution was put to vote. Majority of the members focused on exploring ways we can resolve this issue in a way it doesn't hurt the organization's 503 (c) status and that it doesn't set a precedence.

Resolution: "The current board reviewed the expenses and available information from the previous administration and determined that the expenses were unauthorized. Passed a motion and request the past president and treasurer to repay \$6,929.99 to VSNA by July 03, 2019. Failure to do so will result in further actions by the board".

Shailendra also advised that we should explicitly list the votes as this is a special meeting to address a special issue. Here are the votes as they voted.

Shylendra presented: Recognizing the chapter and inspiring others is a proposal in very early stages proposed by Vijay Kotrappa (BOR Member). The proposal includes a monetary reward as well. BOD will be presented with a detailed proposal after the review by BOR.

Dr. Jagadeesh shared that surplus funds out of their convention could have been used to convert local chapter members to become life members and recognize the chapter for doing an awesome job.

Sajjan Shiva mentioned that officers/BOD cannot make arbitrary decision. Shiva Patil clarified that MD surplus money was above and beyond after returning the seed money to Central VSNA.

Raj called for the action items:

Absentee BOD member issues: How to motivate?

The president has reached out to them but in vain. A few chapters have dwindled down to 1-2 families. However they affect the quorum. Raj emphasized that the ultimate goal is to drive more participation to build a stronger organization. Many other members chimed in their suggestions —a few to mention, change the bylaws to reduce the number constituting the quorum, include all the executive committee members from each chapter to WhatsApp group. Suggestion to get their permission before adding/ Pros and Cons were discussed.

Treasurer's report – Shiva Patil :-

Shiva Patil pointed to the board about some legal expenses incurred by the previous committee without the approval of the board. He requested a clear directive from the board so he could file the taxes before the extended due date September 15th, without jeopardizing the 501(c)3 status of the organization. Srishail has made futile attempts to communicate with the past president and the treasurer to resolve this issue. Also mentioned about similar invoices submitted by party B for payment.

It was decided unanimously to procure a lawyer and Shiva was authorized to spend up to \$1000 which does not need approval as per the bylaw. BOR Updates - Yuvaraj Patil:-

The president Srishail welcomed all the attendees by thanking them for attending this special meeting, He briefed on the urgency of the situation to resolve the issue of an unauthorized spending by the previous administration and reminded of the pending invoices to be paid to the other party for the expenses occurred as a consequence of the actions by the previous administration. Several attempts made to contact the past president either to streamline the expenditure as authorized by obtaining the approval from the previous board or to refund the money were in vain. Today our treasures needs a resolve in the form of meeting minutes so that he can file the taxes within the deadline. He opened the floor for discussion.

Sudha Nagabhushana:- Lot of members are new here and may not be aware of why these charges occurred and may have lot of questions.

Manisha:- No clarifications were provided to the questions asked by the senior members at the general body held at the convention and need to be answered. Srishail:-That is a totally different agenda and today's special meeting is to focus on tax filing and discuss the related issues. This issue is being discussed for the past 8 months and this is Sudha's first meeting. The BOD is aware of this situation and more information can be found in the agenda and meeting minutes of the past meeting minutes.

Indira Reddy:- Requested the details about the general Body meeting conducted at the convention. Many questions were raised as to the procedure, attendance, quorum and the way it ended.

Shylendra:- Explained. After the treasurer's report, the same people who were involved as seniors in this process from the beginning were asking these questions

to the current officers instead of the previous committee. These are the same members referred to in the email exchanges who provided the guidance to the previous committee. The purpose of the GB is to inform the general membership about the state of the Samaja and information only. Any input will be noted and discussed at the BOD for a proper action.

The request at the General Body (GB) meeting was to constitute a special committee to hear from both the sides. Unfortunately there was no quorum to make a motion and the meeting had to be adjourned abruptly due to the chaos.

Jayashree:- Reminded everyone of the importance of today's meeting. What happened at the GB will not help us. In order to get to the bottom of these questions, past officers need to be present. We have about a week's time to file the taxes and need to move forward.

Manisha:- We had 8 months to resolve this and not having enough time to discuss is not an excuse.

Shankar Sanikop:- Yes. For the past 8 months this committee is trying to bring a resolve to this problem. You people being part of BOD, need to take ownership and help take a final decision instead of asking these questions.

Raj:- We have discussed and debated it for 8 months now. Need to resolve it in a way it will not jeopardize the nonprofit status of our organization. All the efforts to collect the money have not yielded. Again, the intent is not to target any individual but the goal today is to resolve it once for all and within the given time frame. We as a responsible BOD agree to absorb those costs and allow our treasurer to file the taxes.

How do we structure this is up to us. Why don't we agree to accept those expenses and explain the circumstances and give it as an endorsement to the treasurer that it is an approved expense so that he can file the taxes?

Tej:- I totally agree with Raj. This is an unforeseen event that has never occurred in the history of VSNA. Just absorb the costs, write the explanation with the help of CPA. Let us give the consensus as a team and move forward.

Many members were very dissatisfied with the spending that one member suggested to revoke the membership of the person/s involved for at least a year to reflect the consequences and such spending will not be accepted by the board.

Girish:- Agree with Raj, absorb, file taxes. Moving forward, we can change the bylaws to prevent its reoccurrence.

Most of the members agreed to this and some who spoke are, **Sudha**, **Kalpana**, **Manisha**, **Nagarathna**, **Tej**, **Priyanka** and **Indira**.

Raj:- Brought up the second part of the resolution, the other party (partyB) has also sent an invoice for their expenses that occurred as a consequence of the same incidence. However it will not cause any further loss to the organization. They have kindly agreed to refund the amount in its entirety.

Rathna:- Requested clarity about what are these expenses and who is party B. **Tej:**- Requested to send their invoices to the members for record keeping only.

Shiva:- Explained that the invoices received were for the last year's expenses incurred by a few BOD/BOR members in seeking legal advice to respond to the legal notices served by the previous president to them.

Sudha:- These people received notices because of the illegalities caused and in hacking the communication platform and deception by these members.

Srishail and others:- Some discussions ensued as to the individual perception and views to consider what is legal and what is not.

Raj:- Read the resolution—

The BOD team proposes a resolution to resolve the unauthorized spending of \$6,929.99 by the previous president and treasurer as below:

The legal expenses were borne by both the parties involved. However party-B did not have VSNA check signing authority, while previous president and treasurer (Party A) used their power to use VSNA funds to pay for their legal expenses. In order to resolve this issue once for all, it is only fair that current BOD accept the expenses of both the parties involved. However Party-B requesting this reimbursement purely on principle of adhering to bylaws and fairness is paying back to VSNA the entire amount. As a result, this will not result in any further expenses to VSNA. The resolution further states that this incident cannot be used as a precedent in the future nor is this endorsement of previous president and treasurer's acts as valid and appropriate. This resolution is making a special exception to absorb the legal expenses of \$6,105 to enable the current treasurer to file VSNA taxes and protect the 501 (c) 3 of our organization. Any invoices or expenses related to this will not be entertained in the future.

Indira Reddy, Manisha and Sudha- Did not agree to the second part, to pay party B. Their opinion was to focus on one thing at a time. Suggested to have another meeting to discuss the validity of payments to party B.

Rathna:- Still not clear on who the party B members are and their charges. **Srishail:**-

Party A: Laxmi Hiremath (Past President), Karuna Hiremath (Past Treasurer)
Party B: Basavaraj mudenur, Prabhakar Chippadi, Dada Patil, Channu
Kamblyal, Yuvaraj Patil and Shylendra Kumar have spent \$6,105.00 in

responding to the legal notices served by the past president.

Sudha insisted that it_needs to be discussed on why they received these legal notices, was there any wrong doing on their part?

Srishail;- This is a question to the party who served the notices. Have been trying for the past 8 months and the president has not replied to any of our emails.

Shankar:- Cautioned us on the 45 minutes spent already and agreed to propose the resolution to accept the expenses borne by both the parties. Need to reimburse party B for their expenses if not paid already.

Indira, Sudha and Manisha were in disagreement to pay the party B. Priyankawanted to see an end to it and suggested considering accepting Party A costs since most have agreed and take party B at another resolution.

Shankar;- People should respect the resolution put forward. Endless argument will not result in a solution. Need to accept the expenditure and need to take a letter from both the parties that no further expenses will be accepted in the future.

Naveen:- My opinion from the discussion we had so far is, if we are OK to pay the party A expenses, we should be OK to pay party B as well, because they are related and are not two different issues. Whatever the decision, take for both the parties and move forward once for all.

Raj was asked to read the resolution once again.

Tej:- Suggested to verify the validity of the invoices claimed by party B and also raised the concerns regarding the financial transactions since the invoices are from 2018 and the payment/reimbursement is occurring in 2019. The recommendation is to consult the CPA to get the suitable language frame to ensure the legal validity of this resolution.

Suggestions were made by others to include the exact amount that will be paid to party B.

With the above modification, the resolution was put to voting with the proposal by ---Shivashankar Sanikop, seconded by-Naveen Kumar.

The resolution was passed by 15 members in agreement, 3-members in disagreement. Could not establish contact with Vijay Aivalli and Rathna from Georgia chapter.

Srishail approved and declared the passing of the resolution

Vasanth: was of the opinion that we should be OK even if the party B doesn't reimburse the amount.

Priyanka:- All the members are in agreement to accept the expenses. Party B is paying back to VSNA with a bigger heart. All volunteers are doing seva. In the best interest of the organization and the pending tax filing issues, let us put an end to this and move forward.

Srishail thanked all the members for their help in making this critical decision and facilitating the tax filing process.

Jayashree Jagadeesh:- Thanked everyone for attending this special meeting and coming together as one team. Also requested the members to put their personal differences aside and work together for the Samaja.

Uma: Since it is called Global convention, are guests from all over the world invited? Raj: yes.

Mahesh: Do attendees from outside the US are involved in decision making process?

Raj: No.

Jayashree: clarified that Invitations have always been sent to all the organizations outside the US. Every year people from outside attend the convention.

Sheela Neral: Agreed that every year outside people are invited. Showed concerns about not having the name VSNA in the convention title, agreeing with Shylendra.

Srishail: International Basava conference has been used by Boston in the past, Vishwa manava Dharma etc names have been in use. The name VA has chosen reflects their chapter's decision and we should honor it.

Nijaguna Prasad: How about balancing both -and include VSNA in the Global Basava Convention or add as a second line.

Continued discussion: regarding the title, Global convention name used by Melbourne, any copyright issues.

Shiva: Have you reached out to other chapters for their opinion?

Raj: Will look into copyright issues. Yes. We will send out the survey to all the 22 chapters.

Updates from the Bylaws review committee - Channu Kambalyal -

Thanked BOD and Srishail having trusted him to complete this task with the help of other bylaw committee members—Shylendra Kumar, Leena Paul,

Yuvaraj Patil, Narendra Hadimani. Thanked the past senior members for writing the constitution and the bylaws. Explained how this was a mega task but much needed. Thanked all the chapter presidents, seniors and many who gave inputs during the convention and many other meetings. The team has spent more than 500 hours and had several meetings in the last 8 months. many changes were made from earlier version. He also mentioned that this is still in the works and this is the initial draft, purely for the members for their review and feedback.

He referred to the link that he had sent earlier. Mainly--Three main changes, The membership structure for Life Membership-Family and individual, Annual Membership-Family and individual, and annual membership--youth.

Refer to Article III: Membership. Fee structure is up to BOD to decide.

Eligibility: To serve as a member of BOD and /or the officers.

Refer to Article VI: Board of Directors section 3.

Some members requested clarity regarding the pre requisite to serve as a president.

Number of BOD members: Removing the extra slots of elected BOD members. Many discussions including the control of spending were addressed.

Srishail: sent a link. Lot of effort has gone into it. It is still a working doc. Suggest how to improve on it. Give your feed back to the bylaw committee or to the president.

Raj: What really would help to understand what is the change what is new compared to old version is some sort of side by side document..

Channu: in summary the change you see in slide #2 referred to the link sent) are the main changes. It is difficult to pin point the changes. There are many structural changes. But will try to have excel spreadsheet with side by side changes to make it easier. Cautioned that the article number may have changed, some deleted. In many cases they rewrote. Old one modified to include changes.

Indira: The number of BOD doesn't match. Now it is chapter presidents plus the nominated, 23+6 = 29.

Channu and Shylendra: That is the suggested change. Remove the elected BOD. The chapter rep should cover each chapter. Youth chapter also have a representation. No need to have elected 6 officers.

Indira: We will be short of those 6 helping hands.

Shylendra: Appreciate any suggestion to include those positions can come up with an issue that causes the organization not to function properly. Again this is a proposal for BOD need to decide and put it up for voting.

As we are all volunteers and serving for a noble cause and full-filling our mission to preserve promote and propagate his divine message. On that note, let's move forward in fulfilling our goals and objectives of the organization.

Flood relief fund:

He thanked all the chapter presidents for their efforts and contributions to the flood relief fund. Still exploring and evaluating a few projects to work under the VSNA banner possibly in Jamakhandi Taluk in Vijayapura and Chikkodi Taluk of Belagavi District. We like to cater to the needs of people globally with the main focus being the youth and the next generation. Identify keynote topic first and then invite the chief guest who can do justice to the topic. A swamiji/non swamiji who can talk about life in America to suit our youth are welcome. Blue print for the convention –Educate, Enrich and Entertain our youth. We want them to come out of the convention saying we learnt something had fun and we want to come back to the next convention. Decided to have two way conversation rather than one way lecture. Give prime time to youth on the stage and have them debate on the theme. Want to align the theme

Kaayaka, Dasoha mattu samaanathe in all our activities

Keynote speaker: Considering Mrs. Sudha Murthy. Would like to seek approval through this BOD.

Prabhakar: Excellent choice. She can relate to current issues. It might be a good idea to take the next step to get the web site updated.

Raj: We have the content ready but can't launch since the 2019 convention team will not release the website until Dec 31st 2019. We will get the web on Jan 1st. If central VSNA can help, it will happen sooner.

Harish: Suggested that BOD should work offline with 2019 committee to Release the website to 2020 team.

Onkar: 2020 Convention's name modification deviates from article #5 in our bylaw. Will this pose Conflict?

Shylendra: Revise the bylaw and make modification since the 2020 convention team took the majority opinion.

Jayashree: Any objection to invite Sudha Murthy as chief guest? Unanimous approval. Proposed by: Nijaguna Prasad. Seconded by :Harish

Nijaguna Prasad: Any standby if this option doesn't work?

This prompted a short discussion and the 2020 committee was suggested to **Compile** a list of 8-10 speakers and get a blanket approval at once.

VSNA Bylaws 2020 Approval- Srishjail Hadimani

Bylaw committee has completed the final draft version. On behalf of BOD we thank the bylaw committee for meeting every weekend and for spending more than 500 hours. Many suggestions and questions raised by the members have been addressed. A draft version has been submitted for BOD. **Shylendra:** Just to clarify, this is only the approval from the BOD. This needs

to go to the general membership for the feed back. Make those changes if any and then put for voting for the final approval.

Prabhakar and Harish expressed that since this is an important document need more time to go through, though it has been discussed at length in the previous meetings.

Srishail: We have shared 3 docs, old and new bylaw and excel spread sheet with modified changes. Many members have sent questions, suggetsions and have sought clarifications.

Mahesh: If you can't just convince the family how can you convince the general members? What issues we had as an organization in the old version and the reasoning behind those modifications is still not clear. It is my bad that didn't go through. Let us put it for voting in the next meeting.

Shylendra: Didn't want to rush through this process but if the next term election takes place in 2020, if it is not approved before January, we will end up in facing the same issues for example of eligibility of the candiadtes etc. One option is to release it to the general membership for commenting, the board can also use this opportunity to comment while the general members review.

Raj: Just pass the resolution to release it for commenting to the general members.

Passed resolution: Bylaw committee presented documents as submitted and shared with all the BOD members be released to general members to receive the comments by December 1st. Proposed by Raj Galagali and seconded by Shiva Patil.

Treasurer's report: Shiva

Party B has gracious returned the check back to us regarding the legal expenses. Thank you very much. Received communication from Chicago convention chair also who wants to send us the check. Need update on the Karnataka relief funds situation need to be addressed ASAP. Taxes have been submitted successfully and accepted by the IRS without any questions. Jayashree extended request to some of the presidents like Harish to rig up some funds from their members to make it a sizable amount.

A few things that we chatted out of the agenda items:

Rohini requested Shylendra if he can find out how we can send donations to India. Shylendra agreed however cautioned that any organization that we send

needs to be recognized by IRS here, otherwise it will run into money laundering. **Shobha:** New England chapter president announced that they will host the 2021 VSNA convention. Approval of Agenda:

Indira Reddy proposed that we change the agenda from approval of bylaws by BOD to continue the discussion of bylaws. This was seconded by Sheela Niral and many others.

Bylaw discussion: Shylendra led the discussion on behalf of bylaw committee. Provided details on restructuring of the content, remapping to new structure. Goal was to provide clear distinct interpretation of the old bylaws. Received feedback from many members during the last 4 weeks. Bylaw committee has gone through each of the response received and incorporated needed changes. These are only recommendations. It is up to BOD to review and provide their feedback. Process is that the BOD has to approve it first. Then it goes to general members for approval.

Naveen from Pittsburgh: Expressed his concerns and objections, around changing from Religious to charitable organization. Girish Budibetta, Indira Reddy and Kalpana expressed the same. Shylendra gave explanation 1. Corporates cannot and do not contribute to religious organization and members are not able to raise. 2. Sharana principle as the primary objective of this organization. Hence there is no religion attached to Basava principles.

Srishail shared that our registration under 501(c) 3-B, we are non-profit charitable organization. It does not say we are a religious organization.

Naveen expressed concerns that the money collected may be misused if we change it from religious to charitable. Vivek feels that this is an experiment and resists the change. Uma said that we should not wait until they age to come back. Rohini strongly felt that we should focus on charity and adapt to the changing times. Prabakar also expressed that just changing to charitable does not mean we are not practicing the religion.

Jayashree summarized that the money collected was for the activities conducted by this organization and not because this is called religious organization or otherwise. Just calling

charitable organization does not mean we lose or give up on what we have been doing for so many years.

Harish agreed that we should change religious to charitable however they do not want anything else to be changed in article 1 and 2.

Conscious efforts were made to have everyone share their thoughts on this important topic. There were points made for and against this change by each of the members present.

Shylendra in summary explained the inconsistencies in our registration, in IRS registration, emblem and details in it, place of worship and everything else. If we need to keep article 1 as it is, one needs to address the issues written in each of these. Bylaw committee aimed to define the registered office address and mailing address and other aspects without contradicting at various other places.

An option to vote just on this single point of changing religious to charitable was explored and It was eventually decided that BOD wanted to see both article 1 and 2 together and then come prepared to vote on it.

Rest of the items were not covered due to shortage of time. This was a 2 hour call.
