To Whom It May Concern,

As truth always prevail, for the second time, the US Courts have upheld the evidence of fraud in VSNA Bylaw Changes 2020 voting process and rejected all the defamation claims alleged by **Mr. Srishail Kumar Hadimani** in its entirety with prejudice. On Dec 14th 2021, Harris County Court, Texas, dismissed Hadimani's Defamation Case seeking \$250,000 monetary relief against Harish Hiremath (VSNA) in its entirety and ordered Plaintiff Hadimani to pay \$6,250 towards court charges and additional \$5,000, if he appeals further.

Background: VSNA Primary Membership of Mr. Srishail Kumar Hadimani was suspended on Dec 6th 2020 by BOD 19-20 and it was unanimously revoked in Jun 2021 by BOD & BOR 21-22. On Aug 16th 2021, Hadimani served us a legal notice challenging the actions taken by BOD's and alleging the related official communications as intentional defamation claiming substantial financial & professional losses.

On Aug 23rd, 2021, the BOD 21-22 authorized the officers by passing VSNA Resolution #2021-7 to retain a professional lawyer to defend VSNA and all its officers against Hadimani's defamation case.

On Oct 14th 2021, VSNA filed a Motion To Dismiss (MTD) the case in its entirety with proof that all the actions taken by defendant & BOD were based on US Court Verdicts and information shared in official communications is within the provisions of US laws.
