

As VSNA Officers, Elected BOD, Chapter Officials including Youth Chapter are indemnified and legal protection is provided to them as per VSNA Bylaws, Article XV Indemnification, Section 2: Indemnification of Directors and Officers; Section 3: Indemnification of Employees and Agents, the VSNA Board of Directors authorizes the officers to utilize VSNA funds to provide needed protection and legal expenses, not to exceed \$10,000.

Article XV Indemnification, Section 2: Indemnification of Directors and Officers: The Corporation shall indemnify and advance expenses to a director, regent, or officer of the Corporation in connection with a proceeding to the fullest extent permitted by and in accordance with the Indemnification Section.

Section 3: Indemnification of Employees and Agents: With respect to an employee or agent, other than a director, regent or officer, of the Corporation, the Corporation shall, as determined by the Board of Directors and Board of Regents of the Corporation, indemnify and advance expenses to such employee or agent in connection with a proceeding to the extent permitted by and in accordance with the Indemnification Section.

Background for the Proposed VSNA Resolution # 2021- 5: by Girish Budibetta

A: VSNA Special BOD Minutes of Meeting – Conducted on Sunday, December 6th, 2020 @ 12:00 to 1:00 PM EST:

Resolution Passed by Majority Board:

Mr. Srishailkumar Hadimani, having been accused of allegedly 'falsifying a document/forgery' a crime under USA laws, and his refusal to respond or exonerate himself from suspicion, demonstrates 'conduct unbecoming, and detrimental to the goals and objectives of the Religious Corporation' In an attempt to safeguard the image, reputation, legal and financial interests of VSNA, we the Board of Directors are forced to do our bitter duty, to suspend Mr. Srishailkumar Hadimani from the VSNA membership, until such a time he, or the courts/agencies, clear his name from suspicion of the 'alleged crime'.

Current Status: Even after six months, Mr. Hadimani has failed to provide the anticipated and needed proof to exonerate himself from suspicion of the 'alleged crime' which calls for further action by the VSNA organization.

B: The Circuit Court for the County of Oakland, State of Michigan – Entered Declaratory Judgement, March 26th, 2021:

On Feb 8th, 2021, The Circuit Court for the County of Oakland, State of Michigan issued a Motion to Compel Discovery to VSNA with respect to the legal case over the VSNA Bylaws 2020 Voting Process. It forced us to Discover, Verify and Submit all the related documentation within 30 days, by Mar 10, 2021.

Our key goal was to protect our organization from contempt of the court and avoid possible penalties by not fulfilling the court order. We shared all the collected data along with the discrepancies with previous and current BOD & BOR for the comments. After incorporating the comments received, we submitted the documentation to the court. With this submission, the legal case in which VSNA had got entangled was CLOSED and the court issued the Declaratory Judgement.

Excerpt from the recorded judgment: "IT IS FURTHER ORDERED, ADJUDGED, AND DECLARED, that there is evidence of fraud in the voting process by the "System Administrator", Srishail K. Hadimani, and improprieties in tabulating the vote."

Such proven fraudulent behavior can be legally dealt and can be further tried in a court of criminal law, if pursued. After consulting with most of the current board members and advisors, the following action internally within the VSNA organization is proposed.

To be fraudulently manipulating votes, as the President and a Sharana, is the ultimate dereliction of duty.

Compelling Reasons for Current BOD action: By Bhavani Moodabagil

- 1. When some wrongs have been committed, as a religious organization. which upholds principles & ethics, must call out and condemn such acts. The Samaja's beliefs and principles must be demonstrated, and all attempts must be made to right these wrongs.
- 2.If there are no consequences to violating our basic principles, our bylaws, and hurting the organization, any elected leaders can abuse their position, power and inflict irrecoverable damages to our organization.
- 3. Since these acts have become a public record, VSNA, as an organization, must openly condemn these acts of abuse and must take necessary action. If not, the hypocrisy will damage the reputation and standing of VSNA, and we may be seen as party to a coverup and will lose our credibility as the leadership group.
- 4.It is also our responsibility to alert other such organizations, who would receive these violators with trust, into their fold, as former officers of the esteemed VSNA.

VSNA Resolution # 2021–5: Revocation of Primary Membership of Mr. Shrishail Kumar Hadimani. By Shrikanth Hanumanthappa.

- 1.Mr. Srishail Kumar Hadimani, having been accused of allegedly 'falsifying a document/forgery', a crime under US laws, and unwilling to exonerate himself despite many opportunities presented to him. The Board of Directors (BOD) had suspended his VSNA membership on Dec 6th, 2020, until he could clear his name from suspicion of the 'alleged crime'. Even after six months of waiting, Mr. Hadimani has refused, failed and not even attempted to provide the anticipated & needed proof. (Attachment # 1: Special BOD Minutes of Meeting, Sunday, Dec 6th, 2020)
- 2. The Circuit Court for the County of Oakland, State of Michigan Entered Declaratory Judgement, March 26th, 2021: Excerpt from the recorded judgment: "IT IS FURTHER ORDERED, ADJUDGED, AND DECLARED, that there is evidence of fraud in the voting process by the "System Administrator", Srishail K. Hadimani, and improprieties in tabulating the vote. (Attachment # 2: Declaratory Judgment, March 25th, 2021)
- 3. Srishail Hadimani is responsible for multiple counts of bylaw violations, overriding several majority BOD resolutions while continuing to mislead and misinform the general members. He engaged VSNA in a legal counter challenge going against explicit BOD mandate, direction & resolutions. (Attachment # 3: Special BOD Minutes of Meeting, Sunday, Aug 16th, 2020)

Seconded By - Nijaguna Prasad and Bhavani Moodabagil

After brief comments by Nijaguna Prasad, Harish Hiremath asked for any further comments and no one volunteered for any further comments or discussions. Hence, the formal voice voting was called for and the resolution was voted as follows: Abstain = 0, No one Abstained; No = 0, No one objected; Hence the resolution was passed unanimously by all the members of the board.

Next Mr. Harish Hiremath proposed "VSNA BOD Recognition of Integrity & Service to VSNA by Shiva Patil" and appreciated the service to VSNA by Mr. Shiva Patil.

VSNA BOD 2021-22, APPRECIATE AND COMMEND the services and efforts of Shiva Patil, Treasurer for 2019-2020 BOD, for adhering to the bylaws, honoring the majority Board of Director's resolutions, and safeguarding the monetary assets of VSNA in an exceedingly difficult time. VSNA Convention Observations of 2021 & Recommendations for 2022

As Quorum was not formed, Mr. Harish Hiremath started the meeting with discussing the observations of the VSNA convention 2021 and recommendations for the 2022 VSNA convention. It was an open discussion to brainstorm how we can improve, what we would like to do for the 2022 convention. For discussed on the following items.

- a. On-site (like traditional way)
- b. Hybrid (On-site & Partially Virtual)
- c. Virtual (Similar to 2021)

Here are all the views put forth by all the attendees and recommendations.

Girish Budibetta: Difficult to predict. If in person quite challenging if Covid continues. Wait little longer decide, assess situation February/March and if okay try to come up with different date instead of July 4th weekend.

Suresh Sharoff: Agree with Girish. Hoping we will be out of Covid by March and we might have to decide at that time. Also, Doctors are reasonably optimistic that we will be out of Covid by Feb/March.

Nandish Dhananjaya: Echo same thing what Girish and Suresh. For any venue reservations we must plan 6-8 months before, but we have to make sure there is no penalty for cancelling the convention hall if we can't hold in person convention. So better we go for virtual next year if we are hosting in July. Otherwise take call in November/December.

Roopa Guddimath: VA was supposed to host last one before the Pandemic. She will go with the Virtual. If we go with in person, it is difficult to the pull the crowd. Last time we lost approximately \$3000 in cancellations.

Sudhir Naikar: He will vote for Hybrid.

Sidd Timkur: Vote for virtual. Last virtual event was good, but we need to think on how we can pull more chapters and involve everyone/get more crowd.

Srikanth Hanumanthappa: We should be prepared for Physical event and more talent from USA and Canada.

Thumbesh Halnur: Vote for virtual as situation is still fluid. Increase participation as personally had difficulty in getting more people.

Jay Jayadev: Virtual is great but we got mixed results. So better to go with Physical. it is not going to be successful the way physical works.

Nijaguna Prasad: Too early to decide. Go with wait and see approach as even if we decide now on with Virtual or Physical event there will be lot of effort goes behind the scenes.

Onkara Murundi: In our chapter we are going with virtual events. Initially participation was good but now it is dwindling out. But personally, I feel we have to go with virtual next 6-8 moths. Get survey from all members outside of BOD.

Sajjan Shiva: Don't commit anything for physical next year. But In person is always better than zoom. Be ready for in person and roll back to online if necessary.

Nagarathna Totada: Agree with Sajjan S. It is too early to decide on anything. But if go with virtual event we have to work with chapters to mobilize more folks.

Kiran Babaladi: Vote for in person event but too early to decide on it.

Santoshkumar Teli: In person rather than virtual event.

Bhavani Moodabagil: Based on what we are seeing everywhere including at work, vote for in person event. We should work with hotels or convention halls so that if we need to cancel, we should not be penalized. If planning for in person scale it down as turn out might be low not like regular events in the past.

Harish Hiremath: With Covid still people are not participating in huge numbers. So, we should be open for all three options. For virtual event we can decide later but Physical event or Hybrid we have to start planning it now. Early next year we can take the decision, but we have to start the planning for physical now. If some chapter wants to come forward, then we can start working on it.

In light of the many accusations recently made by various members against various members, our client rightfully believes transparency is critical to the success and future of VSNA moving forward. Please kindly confirm that VSNA will timely comply with the requests made in this letter, and advise me of any further information or steps required for VSNA to complete the production requested.

GG's Request for Documents in Demand Letters on Jun 23rd, 2021 & Jul 19th, 2021:

- 1. For the past three years, the books and records of account and minutes of the proceedings of board, and executive committee including the attendance records.
- 2. A list of the names (addresses may be redacted, if necessary) of all members.
- 3. All such records concerning the formation of two new chapters in San Antonio, Texas and Alberta, Canada.
- 4. Documents sufficient to identity the length and tenure of the following chapter presidents: Shivashankar Tumkur (AL), K Channabasappa (TN), and Vivek Neginhal (WV).
- 5. VSNA's latest annual financial statements, balance sheet, income statement, and statement of source and application of funds.
- 6. The financial statements, balance sheets, income statements, and statements of source and application of funds for the time period "2010 to Present".

Thank you for speaking with me the other week. Please promptly forward this correspondence to all members who have decision making authority in this matter.

Further to our call, I have consulted with my client regarding your position that he possesses some or all the information requested and confirmed that he does not, nor would it relieve VSNA of its obligations to comply with this request if he did.

Mr. Gangadarappa has been very patient with VSNA in regards to this request (see attachments). I have requested via follow up letter and via phone call that VSNA comply with the requests and have invited on both occasions an amicable discussion regarding the scope of the documents to be produced and a timeline for their production. To date, we have not received any written response nor agreement to make the statutorily required production of documents.

During our discussion, you stated that VSNA may ultimately comply but that it had not done so because the Board believes that Mr. Gangadarappa has "a history of harassing" other members, and that they are therefore unwilling to deal with him. Indeed, you called this request "a very reasonable request from any life member" *other* than Mr. Gangadarappa. I advised that I have no knowledge of such alleged conduct but that, in any event, it is irrelevant to this request for corporate records. The vast majority of the records sought are required to be produced irrespective of the purpose for which they are sought, and only one category requires a "proper purpose."
