
Please review the DRAFT Gift Agreement developed between Doddamani & VSNA with the guidance of Morgan & Stanley with respect to the mega donation made by Doddamani family. Doddamani wanted to leave the selection of Charitable Organizations entirely to VSNA to decide later, but to avoid future controversies, we have agreed on the beneficiaries and have indicated in this agreement. As a next step, we will be getting it reviewed by attorneys before finalizing.

We have provided the following hypothetical "What if" scenario (worked out by Morgan & Stanley) to understand and further appreciate the true significance of the mega donation made by Doddamani to VSNA. If Doddamani had donated this amount in the year 2000, while taking into account all the market instability we had over the years, the resulting outcome at the year 2020. This is based on transferring 5% of the Gift Fund market value to the VSNA Operating Account at the end of every year, thus providing a constant stream of revenue (around \$5,000) for the next twenty years.

In the provided "What if" scenario from 2000 to 2020, VSNA received \$128,000 (around \$6,400 every year) in twenty years and an additional sum of \$72.3K after distributing \$100K to charities at the end of twenty years. We shall hope the market performance for next twenty years will be similar! For more details, look at the summary details below and more detailed analysis by Morgan & Stanley attached along with the draft Gift Agreement.

\$100,000 initial investment on 01/01/2000. Dividends and capital gains are reinvested. Withdrawals of 5.00% (annually) of the year-end value from 02/01/2000 to 12/31/2020 every month, on the last day of the month as long as funds are available. Agenda Item 6: VSNA Convention 2022 - Discussion

Discussion: Start Time: 2:18 PM EST

Mr. Harish Hiremath presented the Convention facility and lodging venues. Discussed how it saved money by splitting lodging with convention venue facility instead of going under one roof. For lodging negotiated a price with Hilton for \$89 per day. Convention will be of two-day event Saturday and Sunday but still need to finalize the program list. Friday evening is still undecided. It is depending on how many people coming into Houston from outside. There is still lot of uncertainty because people are going to India after the pandemic and significant financial risk.

Houston is a small chapter and unable to host the convention on their own. Hence as a deviation to Bylaws, Central VSNA is taking total financial risk & responsibility with volunteer support from Houston Chapter. As this is the first time in history of VSNA, Central is taking financial responjointly in hosting the convention, we request strong participation, support and guidance from all the board members.

The venue facility India House is a nonprofit organization and because VSNA is a nonprofit organization, they have given huge discount to VSNA. The venue will hold / cater up to 500 people. We will get to know more on the attendance in a months' time as we are releasing early bird package this week. Early bird will end on May 15. For early bird package we are thinking about \$125 which is very low. This is lower than the last convention held at Chicago with was \$140.

Mr. Harish requested if anyone knows talented artists. Also mentioned due to finance constraints, convention can't sponsor their air fares and they have to make their own arrangements/costs. We might be able to relax these conditions later depending on how much donations/registrations funds collected.

Mr. Virupaksha requested Harish to send the formal separate email for requesting donations.

Mr. Harish replied saying we are working on registration forms and trying to automate google forms where members can pay online for registrations.

Mr. Kiran congratulated Harish & VSNA Officers for taking lead in organizing this on-site convention along with the support from Houston Chapter.

Mr. Nandi asked general question on financial viability if registration is less than 300? Mr. Harish replied even with 200 we should be able to conduct this convention ad within Texas there are 4 chapters.

Mr. Harish mentioned by splitting the venue we have saved at least \$35-40K and hotel is not far from the venue. The distance between India House and Hilton is about 8 miles.

Mr. Girish mentioned by splitting venue we will save lot of money especially facilities like Hilton or anyone charges based on per plate which is going to be very expensive.

Mr. Nandi asked about the transportation. Mr. Harish mentioned that committee is planning to have a bus running between facility and hotel which is part of the budget, but we will decide on logistics depending on how many people need it.

Mr. Harish thanked Mrs. Bhavani as she is working behind the scenes on reviewing all the key contracts, co signatory for Convention Account and taking lead in the fund-raising committee. Mrs Nagarathna is also actively participating in the convention activities from the Central VSNA.

Mr. Dilip congratulated and said facility is the big decision which is already finalized and then conducting inperson is a huge thing. He wished for a successful convention.

Mr. Onkara said venue is a good one. Also, transportation is not a problem especially places like Houston. He recommended to think on catering to different age group people so that it is more attractive, and people will come. Also, he recommended to include Audio / Video in the budget. He gave details on the NJ/NY conference details. There were many people outside of VSNA (like other Kannadigas / Maharashtrians/Tamilians) have come along with that they had options for people coming in for 1 day / 2 days etc. He talked about Gururaj Karjagi as he is a very good VSNA speaker who is already in USA, and we can invite him to the convention.

Mr. Harish said they are working on it and one of them is organizing the NASA tour.

Mr. Santosh said he had question on the transportation which was already answered earlier. Also, they have a meeting for Basava Jayanti on May 3^{rd,} and he will invite Mr. Harish.

Meeting started at 2:00 PM EST. Quorum was formed at 2:15 PM EST. President Mr. Harish Hiremath started with the Chanting and Vachana "Shileyolagana Pavakanante, Udakadolagana Pratibimbadante" (ಶಿಲೆಯೊಳಗಣ ಪಾವಕನಂತೆ) by Allam Prabhu.

Proposed agenda was presented to the board and there were no objections to the proposed Agenda sent out. Also in this meeting, there was nothing put it on the table which was required for voting by everyone who attended the meeting.

Discussion: Start Time: 2:56 PM EST

Mr. Harish started the meeting by talking about the VSNA 45th convention and went through the information which was already communicated to everyone on the convention facility venue, lodging facility (Hilton hotel) and other logistics.

He explained how we ended up with the physical convention. In the late 3rd quarter of last year, many of the BOD members were on board with the physical convention but decision was pending because of many uncertainties. Houston chapter committee mentioned they were interested in hosting the convention, but they are not willing to take the financial risk & responsibility for the onsite convention. But decision was put on hold till December/January because of the new Covid wave. In February 2022 board decided to hold the onsite convention agreeing to Central VSNA taking the lead along with full financial responsibility and accountability. Houston chapter will join together to provide the volunteer support needed to run the convention.

After this clear agreement, Houston chapter members elected unanimously Anuradha Gubbi and Mamatha Kumari as Chair and Co-chair from Houston Chapter. Harish Hiremath and Nagarathna Totada represented as Chair/Treasurer and Co-chair from Central VSNA. Central VSNA opened a temporary account in Bank of America under their existing account and started the convention related activities.

As of May 1^{st,} almost 45 people have registered. Almost 15 rooms have been booked as well. Already fundraising committee called all life members once atleast and informing them about the convention. Also involved local chapters like Dallas, Austin and San Antonio and San Antonio chapter is providing more support than expected. So far \$6000 donations have been collected.

He requested all other BOD and chapter presidents to explain how each, and everyone can help in to make this convention successful.

All Presidents and BOD members talked about how they are going to help and how they have started already outreaching people from their respective chapters.

Mr. Jay Jayadev mentioned they are already talking about and will send some good donation from Georgia chapter. Every message comes from convention goes through all members in Georgia chapter. Goal is to have 5-6 families to attend the convention. Also recommended to create an FAQ with all the queries for the convention especially with the Covid is still lingering.

Mr. Hebbani Lokesh mentioned they are outreaching people, and they are anticipating 5-6 families to attend the convention. Also, all the communications are going out immediately. One suggestion was to announce or come up with the program list. Another recommendation is to contact Karnataka government to send some artists as it will help to gather people.

Mr. Harish said Muruga Sharanaru already accepted the invitation and Suttur Swamiji is almost accepted. We are trying to get sponsorship for the artists and will announce in the next couple of weeks.

Mr. Onkara Murundi they are already sending communications out and requesting families to attend. If they can't attend see whether they can donate some money towards the convention. Also, from the chapter they are sending \$500 as a donation to the convention.

Mrs. Chaitannya Mallikarjun is leading medical and health board. Pretty much all active members from San Antonio are involved in the convention as part of one or another committee. As of now 5 families out of 10 have already been registered. Also, San Antonio chapter is planning to have children competition.

Mr. Manohar Mutnal from Austin chapter is encouraging people to register for the convention. Also, he requested some guidance on how to raise the funds as Austin is relatively very new chapter.

Mr. Mahantesh Nashi from Dallas chapter thanked Harish for visiting the Dallas chapter weekend program. They are hoping to have a very good response as they have some exposure of hosting the convention before.

Mr. Sudhir Naikar sending out all the communications to the chapter members. They are meeting members in person and hope members register soon and working on collecting donations.

Mr. Kiran Shivappagoudar as other chapters are doing, sending out communications to all members. They are forming a committee so that they can reach out to people and then see whether they can collectively go together to the convention.

Mr. Nijaguna Prasad mentioned he is in inline with all the great ideas which everyone one presented. Also, he seconded creating the FAQ so that members will get their queries answered. Mr. Harish mentioned we need to encourage local artists from Maryland has many of them are accomplished artists.

Mr. Santoshkumar Teli will invite Harish to talk to members in their local chapter events so that Harish can address members directly. Requested including him the fund-raising committee.

Mr. Mahesh Patil mentioned Detroit has many senior leaders and as Mr. Santoshkumar mentioned we will talk and raise funds for the convention. Harish requested Mr. Mahesh to work with Mr. Jay with the business forum for the convention.

Mrs. Vidya Takkalaki mentioned she has already spread the word to all the members and did talk in the Shivaratri celebrations. She is encouraging members to participate in the programs.

Mr. Aakash Angadi mentioned they have Basava Jayanthi celebration on May 14th and connect personally with individually. He will talk about the requesting donations.

Mr. Nandish Dhananjaya mentioned they are discussing on attending the convention and will help any of the convention ideas with all the lesson learnt documents. They are stressing on attending the convention.

Mr. Dilip Sivanna said they meet 10-12 times within a year and the communication within Georgia chapter is excellent. He recommended meeting in person which grows more bondness which he has seen within the chapter.

Mr. Thumbesh Halnur mentioned this week was difficult with some tragedy but as he had mentioned earlier there is a conflict with one marriage and 7-8 families are attending it including himself. He is trying his best to see whether anyone else can attend the convention.

Mr. Srikanth Hanumanthappa mentioned on the VSNA matrimonial Committee "Sammilana" program, hoping many folks register and he will send out the flyer on the same.

Mr. Nandi Nagaraj mentioned as other chapters, they are passing all the communications to the members without any delay. For donations they have target of \$2000 and collecting as much as possible and send it out. Also working on members participating in the convention.

Mrs. Kavya Hiremath spoke about the fund raising. She has already called all life member and providing them the information with the convention. Few have communicated that they will attend the convention, and few have said they can't, but she is requesting them to donate money.

Mrs. Anuradha Gubbi mentioned that this opportunity motivated her, and she is very happy to meet everyone at Houston.

Mr. Kiran Babaladi mentioned it is excellent to have the convention in person and working on talking to folks within the Florida chapter. Also checking with Artistes whether they can come on their own and perform where we are not able to sponsor for their travel.

Mrs. Bhavani Moodabagil mentioned that it is better for all presidents to talk to members to provide one small/short program that will help with the registrations etc. In Chicago chapter they are encouraging people to take package this will help to register as well donate some extra money.

Mr. Harish mentioned so far it is going on well and the early bird registration ends on May 15th and hoping to have more registrations by that time.

Proposed agenda was presented to the board and there were no objections to the proposed Agenda sent out.

Discussion: Start Time: 2:08 PM EST

Mr. Harish provided the detailed update on the VSNA 45th convention to the board members. He mentioned as of now following items have been committed.

- 1. Facility Program and Guest Room
- 2. Decorations
- 3. Logistics for transporting (arranging vans) people from Hilton to India house. This week sending out survey to get the number of people attending from outside. Right now, 50-60 people have registered from outside of Texas.

Food Contract will be finalized in next couple of weeks. Getting north Karnataka items like Jolad Rotti, Chutney powders etc from Belgaum.

Invited many Swamijis but not financing any one as part of the convention. If they come up to Houston, then we are taking responsibility of arranging guest room and registration fees for only Swamijis but not for other accompanying guests. They must manage on their own accommodation and have to pay for registration fees.

Dr. Shivamurthy Murugha Sharanaru from ChitraDurga have confirmed. Invited Sutturu Swamiji but they have declined because of other commitments. Shivaganga Swamiji from Tumkur is coming. One of the VSNA member is sponsoring for his visit. Also invited one blind Swamiji, Basavananda from Dharwad and he is very good orator. Some one is sponsoring him but currently he doesn't have the Visa. So we are not sure whether he will get visa intime. Invited Shivakumar Swamiji from Tumkur who had accepted but now not coming because of other commitments.

As a main chief guest Dr. C Somashekar president of Basava Vedika Bangalore, is volunteered to come here. He has attended many conventions before as guest.

Invitation also sent to chief minister Mr. Basavaraj Bommai. We have not received any confirmation yet on his attendance, but he has said he will send a message.

Contacted Mr. B. S. Yediyurappa and he is unable to attend but will send the message. We have sent him the format. We have received one more sponsor for his son Vijayendra and he is willing to come on his own.

Regarding invited artists we are mainly encouraging local artists for the convention. Some of the artists are Usha Prabhu from San Francisco, Shivaranjani from New Jersey, few classical singers from Houston and San Antonio, and few singers from Virginia and Dallas. The main idea will be to have two evenings of musical events. Saturday evening mainly for the devotional and Sunday evening is for Orchestra. For the Orchestra, it is a local artists formed the group and performing on Sunday evening.

In the history of VSNA, this is the first convention where central VSNA is taking full financial responsibility with the support from the Houston Chapter to organize this convention. As the central VSNA taking the financial responsibility, there is no necessity to transfer the seed money to the Houston chapter. Instead, we (Bhavani and Harish) created a separate account "VSNA 45th Convention" in Bank of America and transferred the seed money. It is still managed by Central VSNA officers (Treasurer & President). So, all registrations, donations etc are directly coming in to Central VSNA account. Houston is offering only the volunteer efforts. This is the reason why we didn't pass the explicit resolution in the Board meeting for \$19K seed money transfer.

Also Mr. Harish said he is saying this from the beginning, in all board meeting, where central VSNA will take financial responsibility. This is the first time it is done like this as no chapter came forward to host the convention on their own taking full financial responsibility like previous conventions. If Central VSNA has not taken this risk, this convention would not have been happening.

Mr. Girish mentioned this year it was different situation as we are coming out of pandemic but in future as a risk aversion no chapter may want to take the full financial responsibility and risk. It is easier to say let central VSNA take financial responsibility. Even big chapters like Chicago or New England might not take the responsibility and this may set the precedence that Central VSNA will take the full financial burden. These conventions always have been self-reliant with full financial responsibility taken by the hos chapters and Central VSNA has played the role of providing seed money. He also asked whether we have funds in the central VSNA? Whether budget has been proposed to the board.

Mr. Harish said we have the seed money as sent in the email which was \$19K. And other board members are helping to raise the funds and he is expecting to raise \$30K in funds. Ohio chapter already donated some small amount. San Antonio already raised about \$6K. As of today, we have collected about \$18K in donations. Another \$12K is expected as part of the initial budget estimation.

Mr. Harish presented the budget for the convention screen shot of which is attached below.

After reviewing the above numbers Mr. Girish felt it is feasible and other members also agreed.

Mrs. Kavya Hiremath leading the fund raising and have created the Amantrana committee which is calling each Dallas Chapter members as only 4 families have registered so far. Also, registration team have already called all life members.

Mr. Harish asked how everyone can help to raise funds from their respective chapters.

Mr. Girish mentioned if every chapter can donate \$500 then we should be able to cover the \$12 K difference as we have almost 23 chapters.

Mr. Harish also mentioned that as part of going with India house and lodging separately instead of all under one roof, it saved almost \$30K. If we can raise \$12K we should be able to save some money and give it back to central VSNA.

Mr. Jay mentioned the chapter already approved \$1500 and will send the check soon.

Mr. Harish mentioned if we model like this, we can take the convention to many places where we have smaller chapters and not just limiting to few big chapters to host the conventions.

Mrs. Kavya Hiremath said she will try to call all the chapter presidents, life members and previous donors and raise the balance donations.

Mr. Nijaguna said they are motivating all members and passing all the information to members. One thing we heard is many members are planning to visit India. Also, they will check and donate \$500 as they are doing it every year.

Mrs. Poornima said they are passing all the communications to the members, and they have cancelled Basava Jayanti which was supposed to happen in 10-12 days. But they are working hard to collect the money. Also, many families are going to wedding happening in the NY.

Mr. Virupaksha said they are passing all the communications to chapter members and also requested for the donation and attend the convention.

Mr. Santoshkumar said couple of chapter members are coming to convention. He will try his best to raise the donation.

Mr. Jay mentioned 4-5 families might have already registered and will donate rest \$1500. Any convention happening in the future must be in the collaborative way. So, moving forward we have to brainstorm and come up with different tactics to conduct conventions. It should not be difficult for us raise the funds and conduct the convention.

Mrs. Anuradha Gubbi, Convention Chair from Houston, mentioned she is very optimistic, and convention will go well.

Mr. Chayapathy's Lawyers are dragging the case. We have provided all the information and minutes of the meeting from 2018. They are not willing to close it. As we have asked them many times on what else they want, they have taken lot of time to reply. So as per our lawyers, If they go Infront of the judge, they are in a weaker position. So, it is impossible for them to impact VSNA. Also, all the costs in this case are covered by insurance.

In case of Mr. Hadimani case, we won in the lower court and court penalized them \$6500. They went to higher court and if they lose, they must pay \$2500. But his case will go for longer time. 6 months or if they go to trial then it might go to 2-3 years.

Discussion: Start Time: 2:10 PM EST

Mr. Harish thanked all organizing committees, all chapter presidents, volunteers, and donors for the successful VSNA 45th Convention. There were lot of encouragement came in from every corner. 18 Agnatha Sharanaru which was main theme of the Samanvaya convention became a Sharana Samanvaya as a content as many folks get to know many of the sharanas.

In addition, we had all the local artists participated in the convention. It showcased how much local talent we have here within USA. On food side, there was one comment saying there were too many options. There was a concern on the expenses just before the convention, but in the last week we got about \$20K in donations. Mr. Guruswamy Ayya volunteered to donate \$5000 for reception dinner on Friday night which was not initially planned. Mr. Harish thanked Mr. Gadigeppa, Mr. Nadish Dhananjaya, Mr. Jay Jayadev, Mrs. Bhavani, Mr. Sajjan Shiva, and Mr. Ravi Bhooplapur for their support and donations.

Mr. Harish Shared the financial report as of July 27^{th,} 2022, as there were couple more pending expenses to be paid like souvenir etc. (Attachment #1: Detailed Financial Report PPT presented).

Mr. Harish talked about some history on the convention. He mentioned for this convention we completely deviated from the bylaws as no chapter came forward to organize the convention. Most of the VSNA board members wanted to have a onsite convention, But Houston chapter was not ready to take any financial

responsibility and offered only volunteer support. Hence, for the first time in VSNA history, the Central VSNA took the total financial responsibility and accountability for organizing and conducting the convention. What it means to Central VSNA? If we are short by \$10K today, I would have called similar meeting of all the board members and would have asked to help us to fund the shortage.

Mrs. Kavya Hiremath took responsibility of fund raising along with Mr. Gadigeppa and Mrs. Bhavani on behalf of central VSNA. Mr. Harish mentioned that among key donors, Dr. Sudhir Kumar, BOR member donated for Basava Dasohi, which was \$9000, Mr. Guruswamy Ayya \$5000 and San Antonio chapter donated \$6000 along with active volunteering.

Mr. Yatish Jakatimath from San Antonio worked actively in the food committee and got all the north Karnataka food from India. He donated all the expenses and food to the convention.

Food expenses is the biggest one which is about 20K. Facility was about 6K etc so total expenses were about \$54.7K. Total Incoming funds is \$110K and expenses were less than 50%.

Mr. Harish mentioned he needed some advice on the remaining surplus funds which are around \$32K. As per the Bylaws, 50% of the Surplus funds belongs to Convention Trust Fund and remaining 50% (\$16K) need to be shared by the organizing chapters (Central VSNA and Houston Chapter). He mentioned that he has already talked to Mr. Gadigeppa, Mrs. Bhavani, Mrs. Nagarathna, Mr. Jay, Mr. Nandish regarding this matter and got differing opinions. Various scenarios have emerged, shall we share it equally with Central VSNA and Houston chapter (50% each - \$8K each) or shall we share with different proportions. Those arguing for different proportions are pointing out the 100% financial responsibility taken by Central VSNA.

As the five-year Chapter President of Houston and current Central VSNA president, I am in a tricky situation with respect to this sharing issue and hence would like to Abstain from voting or indicating my personal position. Hence, the VSNA Board need to decide the apportionment of the balance funds between two organizing partners – Central VSNA & Houston Chapter.

Mr. Gadigeppa said all these years central VSNA didn't take any financial responsibility. So in this specific convention case, the balance surplus amount this additional \$16K should also must go to Convention Trust Fund.

Mr. Sajjan Shiva agreed with what Mr. Gadigeppa said but looking at different angle, so that next time local chapter can come and organize the local chapter share 25% (\$4K) to local chapter and remaining (\$12K) to Central VSNA. But as per by laws all need to go to central VSNA.

Mrs. Bhavani mentioned that she is in line with what Mr. Sajjan Shiva said to incentivize local chapter (\$4K) so that in future other chapters can come forward to host the convention.

Mr. Harish Said next year Georgia chapter coming forward to host the VSNA 46th Convention and taking full financial risk and responsibility of hosting the convention.

Mr. Jay Jayadev said as local chapter put in lot of effort along with donating some money. So, 50%-50% (\$8K each) share good but as Mr. Sajjan and Mrs. Bhavani mentioned keep 25% (\$4k) to the Houston chapter.

Mr. Nandish Dhananjaya said he echoes what Mr. Gadigeppa and Mr. Sajjan Shiva mentioned earlier. But as per By Laws to avoid any future questions from anyone, let 50% (\$8K) goes to Houston chapter and then Houston chapter can donate money to the Convention Trust Fund.

Mrs. Nagarathna Totada said she echoes what Mr. Sajjan, Mr. Jay and Mr. Nandish said.

Mrs. Vidya said, these are all good thoughts. We can keep it open and go with voting. Whatever is the majority saying and we will go with that.

Mr. Swaroop mentioned he partially agreed to what everyone said but some things he doesn't agree. From day ones when he was approached to host the convention this was never discussed, and he was told it was going as per bylaws. If there is any slightly deviating from bylaws, then he totally disagrees what people have said. Also, regarding putting Houston chapter as separate from all chapters what is the purpose? We have equally contributed financially, voluntarily and every aspect of the convention. With this assumption Houston chapter members participated this convention. He said he will strongly disagree If it is just 25% (\$4K) or nothing for the chapter. Even his chapter members are asking for the financial report of this convention. He recommends going with bylaws.

Mr. Sajjan shiva said it is all chapters.

For this Mr. Swaroop countered saying why it is called Houston Chapter and All chapters? Take out Houston chapter and should have said All Chapter convention. Our chapter members were under the impression that they are equally part of this physically, mentally in every possible way to host this convention.

Mr. Harish requested Mr. Swaroop to check the Cordial request and for this Mr. Swaroop said yes, he has checked it but never said we are going against by laws for surplus funds.

Mr. Harish said everyone agrees on the work done by Houston Chapter and no one is questioning about it. But from Day 1, none of the Houston chapter members including the chapter committee were ready to take financial risk. Central VSNA took the responsibility without worrying on negative or surplus funds. He also said the whole VSNA knows about this. This was discussed in the board. If central VSNA was not ready, we never would have had this convention.

Mr. Swaroop said regarding financial aspect on going negative or surplus never discussed in writing with Houston Chapter. He agrees central VSNA taking financial responsibility but equally they have worked hard to raise the money. But now after the convention with having surplus money, you can not say we are giving 25% (\$4K). and Houston chapter disagrees with this one. Mr. Harish agreed and acknowledged the differing opinions of the board members about sharing proportion between the organizing partners Central VSNA and Houston Chapter. He thanked everyone's opinion and said he will send this electronically and take everyone's opinion as we don't have a quorum today.

Agenda Item 6: 7 Amendments

Discussion: Start Time: 3:12 PM EST

Mr. Harish said many seniors have talked to him and requested to make some changes to bylaws by amendments. We worked diligently for the past one year. We can discuss these, but it goes for on and on. Here are 7 amendments we would like to share and discuss. The reasoning behind these etc. We will share this and then vote them by saying yes or no with proper reasoning. If we agree, then we will go to general body and then if we get 2/3rd majority then we will amend it (Attachment #2: VSNA Bylaw 2022 Amendments Details).

First, we present it to BOD and BOR. If approved, then send it to election committee for General body voting.

Amendment 1: Life Membership

Currently it is for the family and voting is for only one person. If someone expires the voting rights go to spouse. So created new life membership with 150% of current life membership so that both couples can vote. With this, we can generate additional \$75K if all current 300 life members can avail this.

Annual Central VSNA membership People misuse this. At the time of the election, we see spike in annual membership. With \$25 annual membership fees if someone registers 200 people by paying \$5000, they can topple the 300 life members votes. This happened last time when bylaw changes were made where life members were not in favor, but 300 annual members voted and changed the life members wish. This is an abuse and we have seen instances like \$500 check from one individual. So we have to put something in to control this where annual chapter members become central VSNA members and take out central member annual membership. Regarding voting, we can give options and go for general body approval.

Option 1: Family life members gets 2 votes (Husband and wife) and individual chapter members have 1 vote.

Option 2: Chapter members have or don't have the voting rights

Both these are controversial but would like to get everyone's opinion.

Amendment 2: Board of director Election Committee

All or Any General body voting needs to be done by the independent Election Committee. Voting with the electronic ballot must be conducted by a third party or an independent appointed body election committee. Candidate can contest only one position in an election.

Amendment 3: Board of Directors.

Life member deadline should be January 1st of the previous year to become eligible for contesting elections.

Amendment 4:

Veerashaiva International Resource Center (VIRC). The good initiatives like Vichara Vedike and other initiatives should be led by VIRC but by the approval of BOD. VIRC Director and Committee should be approved by BOD.

International Basava Jayanti. We can expand this to throughout the world.

VSNA Children Talent Festival. With virtual platform we can expand this as last year we have 140 children. This year we are expected to get 200+ children. Create a group similar like VIRC and continue to work in future with new Officers and BOD.

Amendment 5: Changing Board of Regents to Board of Trustees.

Mr. Gadigeppa explained about this. BOR was initiated long time back 1997, Dr. Munavalli came up with BOR and BOD. In the last 25 years most of the time BOD and BOR are not cooperating well and not working together. So now thinking about taking some powers out of BOR. One example being BOR needs to approve budget. That creates clashes between BOD and BOR.

Create a new Title Board of Trustees (BOT) and transfer responsibility from BOR to BOT. Almost 90% of the powers what BOR has will be transferred to BOT and only 10% we will make the change to give BOD more power to make decision.

Amendment 6: New article Mega donations. Any donations \$50K or more are accepted with or without stipulations by the VSNA officers with an approval from BOD. Any changes to this in future will be approve from the VSNA General body.

Amendment 7: Change VSNA Emblem. Select by ranking new emblems.

Mr. Jay mentioned going forward keep only operations items with the officers like president, VP etc and everything else all decisions must be approved by BOD just like all other corporations so that in future no one will misuse the powers.



We received various responses with respect to the proposed amendments to our VSNA Bylaws. After discussing among VSNA officers, we are sharing following formal response and path forward:

- 1. Methodology used for the proposal of Bylaw Amendments: As per VSNA Bylaws, there is no specific requirement to form a committee to propose any amendment to Bylaws to the BOD. Also, as per VSNA Bylaws there is no set process to follow to submit proposals for amendments to BOD (Article V Board of Directors, Section 11 & 19). Executive Officers or any Board member or any Life member or any committee formed by the BOD can submit the proposal for amendments to Bylaws for the majority approval of BOD. BOD is supreme and what is important is that the majority of BOD members need to approve before taking the amendments to the General Body for voting. As per VSNA Bylaws, BOD doesn't need the approval of BOR for taking the amendments for General Body voting (Article VII Board of Regents, Section 9). VSNA Bylaw clearly spells out ONLY the specific voting requirements for passing the amendments by the General Body (Article XIV Amendments Section 1). Hence, we request you again to review VSNA Bylaws in detail to understand the approach followed by the VSNA Officers is appropriate.
- 2. Pathforward for Proposed Bylaw Amendments: Eventhough, mere majority of Board Members approval is needed to take the current proposed Bylaw Amendments for General Body voting, we believe that it is prudent to achieve NEAR UNANIMOUS Board Approval for such key organization structural changes. Any number of rounds of discussions (as we witnessed in 2020) will not yield the NEAR UNANIMOUS position. Hence, after reviewing the responses and comments from various board members, VSNA Officers have decided to postpone the current VSNA Bylaw Amendment Process and leave it to the 2023-2024 administration and board to take it forward, if needed. 





While conducting the Election Process for 2023-2024, we found the following VSNA Bylaw violations by Mrs. Nayantara Swamy for your immediate corrective action.

VSNA Bylaw Violation #1: In the Life Member Register submitted to EC by VSNA Treasurer, Dr. Mallikarjuna Swamy is a life member with identification # FL-MS100132. Mrs. Nayantara Swamy is also a life member with identification# FL-NS2022362 indicating the date of becoming a life member as Oct 2nd, 2022. Hence, she is not eligible to vote in the current election. Knowing this fact, she has committed fraud as per VSNA Bylaw by sending her vote to elect the officers and board members in the current election.

Article III Corporation Member, Section 1 (C) Eligibility to Vote: A bonafide member whose name is listed in the VSNA membership roster, annual or Life Membership shall have one vote per membership. To be eligible to vote, a member shall have paid the stipulated membership dues at least three (3) months prior to the scheduled election voting date. She was fully aware of it that she become a member only in October 0f 2022.

VSNA Bylaw Violation #2: As Mrs. Nayantara Swamy has become formally a life member of the VSNA organization on Oct 2nd, 2022, she must not continue to be a Board of Regent member as she doesn't qualify to hold any office until Oct, 2nd 2023 as per the bylaw.





Sub: VSNA Chapter Elections Process as per VSNA Bylaws

As per VSNA Bylaws, Article VIII VSNA Chapters, Section 4 & 5, each VSNA chapter must implement the following process when conducting the local chapter election of their officers:

- 1. An Election Committee (preferably three Life Members or Annual Members or at minimum Active Chapter Members) should be appointed by end of the third quarter (end of September) of the election year. Current VSNA Chapter Officers or Committee members must not be part of the Election Committee.
- 2. Election Committee should formally call for nominations for the available positions from paid Chapter Members giving a deadline with sufficient notice (three to four weeks). This is an important step to follow to demonstrate our adherence to VSNA Bylaws and copies of these notifications must be shared with VSNA officers.
- 3. After the Nomination deadline, sufficient time must be provided for the withdrawal of the nomination of candidates (two to three weeks).
- 4. If there are multiple candidates for the same positions, then an election should be conducted by secret ballot to elect the chapter officers democratically.
- 5. Once the Election Committee determines the final list of VSNA Chapter Officers or Committee Members, their names, contact cell phone numbers and email addresses must be shared with VSNA Officers for proper record keeping and to use for communications.
- 6. Elected Chapter Presidents and officers should be preferably VSNA Life Members, or at the minimum, they must become VSNA Annual Members for their term of service.
- 7. Any new Chapter President who is not currently a central VSNA life or annual Member, will not be eligible to vote on VSNA BOD resolutions.

Whenever an officer position becomes vacant, then the same process must to be followed to adhere to the VSNA Bylaws. As per Article VIII VSNA Chapters, Section 6, Central VSNA will not interfere in the elections of a local chapter, but will monitor and ensure Compliance with the VSNA Bylaws. By following this process, as per VSNA Bylaws, we can together demonstrate that each chapter holds a fair democratic process to elect local chapter officers and to avoid complaints & allegations from chapter members.
