- 2. Submit one original of this document. Upon filing, the document will be added to the records of the Corporation, Securities and Land Development Bureau. The original will be returned to the address appearing in the box on the front as evidence of filing.

Since this document will be maintained on optical disk media, it is important that the filing be legible. Documents with poor black and white contrast, or otherwise illegible, will be rejected.

- 3. This document is to be used pursuant to section 182 of the Act for the purpose of amending the articles of incorporation of an ecclesiastical corporation.
- 4. The articles of an ecclesiastical corporation can be amended by the affirmative vote of a majority of the members entitled to vote thereon that are present at a meeting of the members of the corporation called for that purpose pursuant to the bylaws. If a different majority is required by the rules of discipline or by the church policy in any particular case, that requirement controls.
- 5. Item 2 Enter the identification number previously assigned by the Bureau. If this number is unknown, leave it blank.
- 6. This certificate must be signed in ink by the person or persons controlling the temporal affairs of the corporation. All parties signing the certificate are required to appear before a notary. Under each signature, please type or print that person's name and title.
- 7. FEES: Make remittance payable to the State of Michigan. Include corporation name and identification number on check or money order.

# EXHIBIT A AMENDMENT TO ARTICLES OF INCORPORATION VEERASHAIVA SAMAJA OF NORTH AMERICA

## THE ARTICLES OF INCORPORATION OF VEERASHAIVA SAMAJA OF NORTH AMERICA ARE AMENDED TO INCLUDE THE FOLLOWING PROVISIONS:

#### FIFTH

A volunteer director or officer shall have no personal liability to the corporation or its members for a breach of the director's or officer's fiduciary duty except for any of the following: (i) a breach of the director's or officer's duty of loyalty to the corporation or its members; (ii) acts or omissions not in good faith or that involve intentional misconduct or a knowing violation of law; (iii) a violation of MCLA Section 450.255(1); (iv) a transaction from which the director or officer derived an improper personal benefit; (v) an act or omission occurring before the effective date of the provision granting limited liability; or (vi) an act or omission that is grossly negligent.

#### SIXTH

The corporation assumes all liability to any person other than the corporation or its members for all acts or omissions of a volunteer director occurring on or after January 1,1988 incurred in the good faith performance of the volunteer directors's cluties.

#### SEVENTH

The corporation assumes all liability for all acts or omissions of a volunteer director, volunteer officer, or other volunteer occurring on or after the effective date of this Amendment to the Articles of Incorporation if all of the following are met:

- (i) The volunteer was acting or reasonably believed he or she was acting within the scope of his or her authority.
- (ii) The volunteer was acting in good faith.
- (iii) The volunteer's conduct did not amount to gross negligence or willful and wanton misconduct.
- (iv) The volunteer's conduct was not an intentional tort.
- (v) The volunteer's conduct was not a tort arising out of the ownership, maintenance, or use of a motor vehicle for which tort liability may be imposed as provided in section 3135 of the insurance code of 1956, Act No. 218 of the Public Acts of 1956, being section 500.3135 of the Michigan Compiled Laws.
